

Terms of Use

Please read my Terms of Use which set out the contract between you and me.

Introduction

My Website ("Website") promotes the business referred to on it. In these conditions, the business will be referred to as 'my' and/or 'I' and/or 'me'.

The use of my Website is on the following terms ("Terms of Use"). If you do not agree to these Terms of Use, please stop using my Website immediately. By accessing and using my Website you are indicating your acceptance to be bound by these Terms of Use. They are a legal agreement between you and I and can only be amended with my consent. They should be read in conjunction with any details provided on my Website about how my Website operates and the services which are available, including my [Cookies Policy](#) and [Privacy Policy](#).

I reserve the right to change these Terms of Use from time to time without prior notice by changing them on my Website.

Accessing my Website

I cannot guarantee that my Website will operate continuously or without interruptions or be error-free. You must not attempt to interfere with the proper working of my Website and, in particular, you must not attempt to circumvent security, tamper with, hack into, or otherwise disrupt my Website or any computer system, server, router or any other internet-connected device.

You shall not assert or attempt to obtain any such rights and you shall not use, copy, reproduce, modify, publish, transmit, participate in the transfer or sale of, create derivative works from, or in any way exploit, my name, trademarks, logos or other proprietary marks, or any of the content of my Website, in whole or in part, except as provided in these Terms of Use.

If you provide content for my Website

If you provide any material to my Website (for example, by providing ratings and reviews, comments, articles or uploading any other content in any format

(including video) ("User Content") you agree to grant me permission, irrevocably and free of charge, to use the User Content (including adapting it for operational or editorial reasons) in any media worldwide, for my own marketing, research and promotional activities and my internal business purposes which may include providing the User Content to selected third party partners, service providers, social media and networking websites.

You own your User Content at all times, and you continue to have the right to use it in any way you choose.

By providing any User Content to my Website you confirm that such User Content:

- is your own original work or you are authorised to provide it to my Website and that you have the right to give me permission to use it for the purposes set out in these Terms of Use;
- will not contain or promote anything illegal, harmful, misleading, abusive, defamatory (that is, it does not damage someone's good reputation) or anything else that might cause widespread offence or bring me or my business partners into disrepute;
- does not take away or affect any other person's privacy rights, contract rights or any other rights;
- does not contain any virus or other code that may damage, interfere with or otherwise adversely affect the operation of my Website;
- will, if used to promote your own business or services, clearly and openly state your association with the particular business expressly;
- and will not contain any form of mass-mailing or spam.

If you do not want to grant me the permissions set out above, please do not provide any material to my Website.

I have no obligation to publish your User Content on my Website and I retain the right to remove any User Content at any time and for any reason.

I do edit, pre-vet and review User Content displayed on my Website. If you believe that any User Content does not comply with the requirements set out in this paragraph, please notify me immediately. I will then review the User Content and, where I deem it appropriate, remove it within a reasonable time.

My liability

Although I hope my Website will be of interest to users, I accept no liability and offer no warranties or conditions in relation to my Website or its content, to the fullest extent such liability can be excluded by law.

Under no circumstances will I, the owner or operator of my Website, or any other organisation involved in creating, producing, maintaining or distributing my

Website be liable, whether in contract, tort (including negligence), breach of a statutory duty, even if foreseeable, for any loss of:

- profits, sales, business, or revenue;
- business interruption;
- anticipated savings;
- business opportunity, goodwill or reputation;
- use of, or corruption to information;
- or information.

If I do not keep to these conditions, then I will only be liable for losses you have suffered as a direct result. I am not liable to you for any other losses whether such losses are because I have not kept to my obligations or contract, because of something I have done or not done in negligence, due to defamatory statements or liability for a product or otherwise as a result of:

- use of, or inability to use, my Website;

Governing law and jurisdiction

These conditions make up the whole agreement between you and I in how you use my Website.

If a court decides that a condition is not valid, the rest of the conditions will still apply.

The laws of England and Wales apply to your use of my Website and these conditions. I control my Website from within the United Kingdom. However, you can get access to my Website from other places around the world. Although, these places may have different laws from the laws of England and Wales, by using my Website you agree that the laws of England and Wales will apply to everything relating to you using my Website and you agree to keep to these laws.
